A. CEDS Annual Update

Ms. Oddonetto, City of Globe, is working with small businesses to apply for the Paycheck Protection Program. 45 applications have been processed to date. The City of Globe is working with northeastern Arizona companies on a COVID-19 taskforce to serve small businesses.

Mr. Fleetham, Town of Payson, reported that he is now working in the Town Manager's office. The town has released a One Payson campaign for small business support and has gained momentum in the community.
