STAFF RECOMMENDATION: Staff requests approval for the authorization to submit for 5310 grant funds through ADOT's application process to fund the Coordinated Mobility Management Program and duties thereof, which CAG is currently managing, for the next two years (FY16-17 & FY17-18). The funding request for this grant is now on a two-year cycle, as opposed to a one-year cycle in previous years. CAG is requesting \$200,000 (\$100,000 per year) of 5310 grant funds to establish and continually update coordinated mobility plans with CAG Region 5310 program providers.

DISCUSSION:

There is no financial expenditure by CAG or its member entities. Local match will be provided by CAG through In-Kind contributions up to \$50,000 (\$25,000 per year) as a required local match for this grant.

Authorization for the Central Arizona Governments to submit an ADOT 5310 Grant Application for the Position of Mobility Manager for FY16-18

I, Robin Benning, Queen Creek Council Member and the Central Arizona Government's (CAG) Regional Council Chair, do hereby grant permission for the Executive Director, Ken Hall, to submit a 5310 grant application to ADOT in the amount of \$250,000 over the next two fiscal years (FY16-17 & FY17-18), to continue the full time position of Mobility Manager and the duties thereof. CAG and the Sun Corridor Metropolitan Planning Organization (MPO) have entered into a Joint Planning Agreement (JPA) to provide Mobility Management Services within the MPO boundaries through September 30, 2016. CAG and the Sun Corridor MPO is currently in the process amending the JPA for CAG to continue with Mobility Management services for the next two years. We, the Council, understand there is a 20% match required.

The CAG Regional Council is aware that CAG and the Sun Corridor MPO have such an agreement for the current Mobility Management duties and would like to continue to regionally serve as such. The CAG Regional Council will approve the actual application at our May 11, 2016 Regional Council Meeting.
