Re: **CAG FY19-FY29 TIP Amendment: GIL 22-01C | GIL 18-01D/GIL 20-01C | CAG 20-01P**

Dear Mr. Bottjen,

This letter is to inform the Arizona Department of Transportation (ADOT) Multimodal Planning Division of three (3) amendments to the CAG FY2019 – FY2029 Transportation Improvement Program (TIP), which was last approved by the CAG Regional Council on March 2, 2019. The TIP amendments are as follows:

1. **Golden Hill Sidewalk (Project # GIL 22-01C) - CONSTRUCTION**
  - Move construction and allocated funds from FY 2019 to FY 2020.
2. **Colcord Road (Project # GIL 18-01D / GIL 20-01C) – DESIGN & CONSTRUCTION**
  - Needs an additional \$65,000 total in costs to cover Design and Construction
    - A portion of the dedicated “Off-System Bridge” dollars towards construction will be reallocated to cover Design
  - Apply expected credit of **\$10,260.35** from project CAG 18-01P (Regional Traffic Counts) towards construction in FY 2020.
  - Reallocate FY 2020 **Regional Traffic Count (Project # CAG 20-01P)** dollars of **\$50,000** towards construction in FY 2020.
  - Increase STBGP dollars from **\$300,000** to **\$360,260.35**
  - Increase Local Match dollars from **\$90,000** to **\$94,739.65**
3. **Regional Traffic Count (Project # CAG 20-01P)**
  - Reallocate all **\$50,000** towards construction of the “Colcord Road” pavement extension and bridge project (**Project # GIL 20-01C**).
