No one answered the call to the public.

## VII. Standing Reports

A. Member Jurisdictions

## **Payson**

Chair Halberstadt reported on one (1) item:

 Town staff is continuing to complete the design plans for the "Granite Dells Road" project (Project # PAY 19-01D). Final quantities are being calculated, the Public Works Department is working on the plans to relocate the waterlines, and the bid-package are the most recent activities, moving closer to construction.

## Gila County

Mr. Ashbaugh stated that he had a meeting with the ADOT Program Manager and ADOT Finance regarding the **"Golden Hill Road" (Project # GIL 22-01C)** and the **"Main Street" (Project # GIL 09-01T)** projects, in moving forward with advertisement by September 2022. He stated that this is still within the Federal Fiscal Year and is not expecting to move the projects to the FY23, however, he is waiting on updated figures that would require an Administrative Amendment to the TIP. He explained that the original plan was to take some of the "Transportation Enhancement" funds from the "Main Street" project and apply them to the "Golden Hill Road" project. The readjustment would also result in a modification of a loan between ADOT and CAG.

## B. Multi-Modal Planning Division, ADOT

Mr. Randolph reported on seven (7) items:

- 1. ADOT FY23-FY27 Tentative Five-Year Transportation Facilities Construction Program: The State Transportation Board Approved the Five-Year Program at its June 17, 2022 board meeting. The Final 2023-2027 Five-Year Transportation Facilities Construction Program can be viewed at <a href="https://azdot.gov/planning/transportation-programming/current-five-year-program">https://azdot.gov/planning/transportation-programming/current-five-year-program</a>.
- 2. **FY24-28 Planning to Programming Cycle:** ADOT project ranking information was sent to the ADOT Districts, and meeting invites have been sent out for virtual District workshops.
- 3. The HSIP Call for Projects for FY25-FY26 Program Years: Submitted projects are currently under ADOT review.
  - Draft applications were due for review May 31, 2022.
  - TSS/LPA/PMG consolidated comments should have been sent to applicants by July 29, 2022
  - Final applications due to ADOT TSS on August 31, 2022.

The remainder of the HSIP approval schedule will remain the same. ADOT received 56 draft state/local submitted applications for a total of \$98.4 million (includes local matching funds).

- 4. Safe Streets and Roads for All (SS4A) Notice of Funding Opportunity (NOFO): Applications are due September 15, 2022. Additional information and resources about the SS4A Grant Program can be found at <a href="https://www.transportation.gov/SS4A">https://www.transportation.gov/SS4A</a>.
- 5. Long Rang Transportation Plan: WSP has been selected as the consultant for this Plan. The Notice to Proceed was awarded to WSP on May 20, 2022, and the consultant is currently working on deliverables. The kick-off meeting for the public (including COGs/MPOs) will occur later in the year.

- 6. **Statewide Rest Area Study:** Data collection efforts are almost complete, with additional traffic counts remaining. Other tasks not dependent on the traffic counts will move forward. Extensive tribal outreach has also been conducted. The schedule of the project has been impacted. Deliverables and stakeholder outreach will now occur in September 2022.
- 7. Electric Vehicle Infrastructure Plan: The first general stakeholder meeting is occurring the afternoon of July 21, 2022. Future meeting invites have also been sent to the stakeholders. A virtual public meeting was also held on Thursday, July 14, 2022 from 6:00 PM to 7:30 PM. Plan deliverables are being submitted and the plan is due August 1, 2022. ## C. Local Public Agency, ADOT

No updates were provided.

## D. District, Engineers, ADOT

Mr. Ashbaugh read an email provided by Jeff Minefee from the Southeast District. He read that the Southeast District currently does not have any active construction projects. However, many construction projects will be starting soon:

- US 60 lighting project, via HSIP funding, from Cherry Avenue to Radonovich Boulevard.
- Fence repairs due to the fires along SR 177, SR 77, US 60, & US 70.
- Tonto Creek Bridge
- Flood repair damage along US 60 between MP 240 to 245 +/-.

## E. CAG Transportation Planning Update

Mr. Ashbaugh reminded the Committee that the Arizona Rural Transportation Summit is occurring on September 14-15, 2022 at the Harrah's Ak-Chin Casino. He stated that a list of registered State Legislators will be provided in the near future to the Committee.

## VIII. Old Business

## A. Transportation Improvement Program Amendment(s)

Mr. Ashbaugh stated from an earlier conversation that he is expecting to make a few Administrative Amendments regarding the **"Golden Hill Road" (Project # GIL 22-01C)** and the **"Main Street" (Project # GIL 09-01T)** projects in Gila County. He also stated that he submitted an Administrative Amendment for the **"Control Road – Segment 1"** HSIP construction project **(Project # GIL 24-03C)** as there were minor adjustments in the funding amounts per ADOT's request.

No action was taken.

## B. RTAC Legislative Project List

Mr. Ashbaugh recapped the information that was presented last meeting and the direction he was given by the Committee with regards to potential funding through the RTAC initiative for the FY24 State Budget Cycle. He then shared a spreadsheet that was created to show how the potential funds for each of the three funding tiers, would be distributed among all projects listed within the TIP based on that direction given. A 60 percent, 50 percent, and a 40 percent option were presented.

After discussing many possibilities of how the potential funding could be distributed, the Committee directed Mr. Ashbaugh to look at all projects below \$2 million and add a 10 percent increase to design and a 60 percent increase to construction. Any remaining funds should then be split proportionately among the remaining projects above \$2 million. With regards to the Town of Payson HURF Exchange projects listed within the TIP, the Town stated they would provide a 5.7 percent match to show "skin in the game" and to help provide additional funds throughout the proposed initiative. The matching funds would be a portion of the original project total of the given project before adding the increase.

Mr. Powers made the motion to apply a 10 percent increase to design projects, a 60 percent increase to construction projects under \$2 million, and apply the remaining funds proportionately among the projects above \$2 million. Mr. Goodman seconded the motion. The motion passed unanimously.

#### IX. New Business

## A. Election of Vice-Chair

Nominations were opened for Vice-Chair for the remainder of 2022. Mr. Goodman nominated Rick Powers (Globe) as a nomination. Ms. Arredondo seconded the nomination. No other nominations were presented. Mr. Goodman made a motion to close nominations. Mr. Rivera seconded the motion. The motion passed unanimously. Mr. Goodman made a motion to appoint Rick Powers (Globe) as the Vice-Chair for the remainder of 2022. Ms. Arredondo seconded the motion. The motion passed unanimously.

#### B. Round Table

No discussion took place.

## C. Future Agenda Items

Mr. Ashbaugh stated the only known agenda item would be with regards making a final decision on the RTAC Priority Project funding Tiers.

## X. Scheduling of Next Meetings

Chair Halberstadt stated that the next meetings are scheduled for Thursday, August 11, 2022 and Thursday, October 13, 2022.

THIS AGREEMENT is made and entered into this day October 1, 2022, by and between the Sun Corridor Metropolitan Planning Organization, a statutory legal entity established pursuant to the laws of the State of Arizona, hereinafter called "SCMPO", AND the Central Arizona Governments, a statutory legal entity established pursuant to the laws of the State of Arizona, hereinafter called "CAG".

## RECITALS

WHEREAS, SCMPO and CAG are entities established pursuant to ARS§11-952, by Intergovernmental Agreement and consists of duly-constituted governmental entities located within the boundaries of Pinal County, Arizona; and

WHEREAS, SCMPO and CAG as provided in ARS § II-952.02(B)(I) are deemed political subdivisions of the State of Arizona authorized to exercise the powers specified in the Intergovernmental Agreement including, but not limited to, execution of Agreements and expenditure of allocated funds in support of its activities; and

WHEREAS, SCMPO and CAG are administrated by an Executive Board and Regional Council, composed of designees from each member agency, which is responsible for planning, program implementation and control, budgeting and employment of staff; and

WHEREAS, in order to carry out the Mobility Management function for Pinal County, SCMPO and CAG have agreed to enter into a Joint Project Agreement whereby CAG will provide the Mobility Management services for all Transit Programs within the Sun Corridor MPO planning boundaries, within Pinal County; and

WHEREAS, the Mobility Management program is an ADOT reimbursable program, CAG agrees to function as the fiscal agent for this program, and follow all ADOT requirements for reimbursement.

WHEREAS, SCMPO and CAG agree that the management of said program for the Sun Corridor MPO boundaries, within Pinal County, will be under CAG, with input and suggestions from SCMPO staff.

## NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

- 1. **Administration of the Program:** The parties agree that the day to day administration of the program will be the responsibility of CAG;
  - a. Monthly invoicing and reports to ADOT will be the responsibility of CAG;
  - b. Monthly reporting in the ADOT LPA DBE System will be the responsibility of CAG;
  - c. CAG will gather all monthly or quarterly reports from sub-recipients and submit to ADOT within 45 days;
  - d. Management of the Mobility Manager will be the responsibility of CAG, with input, if needed, from SCMPO staff;
  - e. CAG agrees that all deadlines for submission of key documents to ADOT be met in order to keep all SCMPO sub-recipients (programs) eligible for funding.
- 2. **Program Activities:** The parties agree that the following activities and services (at a minimum) will be provide by the Mobility Manager within the SCMPO Planning Boundaries;
  - a. A monthly or bi-monthly Coordination Council meeting will be held, on a rotating basis, one in Gila County and one in Pinal County. Items on the agenda for the meetings should be specific to the needs of the transit programs;
  - b. The Mobility Manager will visit the 5310 and 5311 programs, and potential programs within the region at least two times a year, and at a minimum;
    - i. Develop a good working relationship with each program;
    - ii. Gather detailed data and service/program information;
    - iii. Prepare programs for ADOT/FTA site visits;
    - iv. Provide technical assistance for ADOT e-Grant submission;
    - v. Determine gaps in service and needs for service;
    - vi. Review driver training logs, and provide assistance for training
    - vii. Hold workshops and/or trainings at Coordination Meetings
    - viii. Keep all programs up-to-date with the latest ADOT/FTA information through email or other means.
  - c. CAG will be responsible for the Coordination Plan and updates, to include SCMPO region and their programs.
    - i. SCMPO will provide information and input, if needed.
- 3. **Term of Agreement; Renewal.** The initial term of this Agreement shall commence on October 1, 2022, and shall expire on September 30, 2023. The agreement may be renewed annually with the award of an ADOT Mobility Management Grant to CAG.

- 4. Termination: This Agreement may be terminated:
  - a. At any time by mutual agreement of the Parties
  - b. By either Party without cause upon 180 days written notice to the other Party of intent to terminate.
  - c. For breach of contract upon 10 days written notice by the Party claiming breach to the breaching party; said notice to specify the acts or omissions constituting the alleged breach.
- 5. **Notices.** Notices to be sent pursuant to this Agreement shall be sent regular mail, and/or email, to the following addresses:

- 7. **Conflicts of Interest.** This agreement is subject to the provisions of A.R.S. §38-511 pertaining to conflicts of interest, the pertinent provisions of which are incorporated herein.
